# New Jersey Student Learning Assessments (NJSLA) and New Jersey Graduation Proficiency Assessment (NJGPA) Speech-to-Text and Text-to-Speech Guidance

The purpose of this document is to offer clear and practical guidance to Local Education Agencies (LEAs) on the appropriate provision of accessibility features and accommodations, more specifically Speech-to-Text and/or Text-to-Speech, for students participating in the NJSLA or NJGPA assessments for English Language Arts (ELA), mathematics, or science. Accessibility features are tools or preferences that are either built into the assessment system or provided externally by test administrators. Accessibility features can be used by any student and do not require an Individualized Education Plan (IEP), Section 504 Plan, or multilingual learner plan while accommodations are intended to provide equitable access for students with disabilities, multilingual learners, or multilingual learners with disabilities. It is essential that LEAs carefully review this guidance document to make informed decisions and apply professional judgment and prudence when assigning accessibility features or accommodations tailored to individual student needs. LEAs are strongly encouraged to review both the New Jersey Student Learning Assessment (NJSLA) and New Jersey Graduation Proficiency Assessment (NJGPA) Accessibility Features and Accommodations (AF&A) Manual and the New Jersey Student Learning Assessment (NJSLA) & New Jersey Graduation Proficiency Assessment (NJGPA) Decision-Making Process Manual for guidance to ensure that state assessments produce valid results for all students. - BX ELA Selected Response or Technology Enhanced Items = 01 (Speech-to-Text)

**Expected Outcome** – The student will be assigned the Non-Screen Reader form with Co:Writer and Read&Write extensions available within TestNav. **Note:** The Text-to-Speech functionality with Read&Write extension is available.
